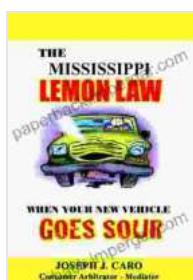


The Mississippi Lemon Law: When Your New Vehicle Goes Sour

* Has a serious safety defect that could cause bodily harm or death * Has a defect that impairs the vehicle's use, value, or safety * Has been out of service for repairs for more than 30 days in the first 18 months of ownership * Has had four or more repair attempts for the same defect within the warranty period

Who is Covered by the Lemon Law?

The Mississippi Lemon Law applies to new vehicles Free Download or leased in Mississippi by:

* Individuals * Families * Small businesses

The law does not cover used vehicles, commercial vehicles, or vehicles with over 10,000 miles on the odometer at the time of Free Download.

What Are the Remedies Under the Lemon Law?

If you believe your vehicle is a lemon, you may be entitled to one of the following remedies:

* **Replacement Vehicle:** The manufacturer must replace your vehicle with a new one of comparable value. * **Refund:** The manufacturer must refund the full Free Download price of your vehicle, including taxes and fees. * **ReFree Download:** The manufacturer must reFree Download your vehicle and pay you the Free Download price minus a reasonable allowance for use.

How to File a Lemon Law Claim

To file a lemon law claim in Mississippi, you must:

1. Contact the manufacturer in writing and provide details of the vehicle's defects. 2. Give the manufacturer a reasonable opportunity to repair the vehicle. 3. If the manufacturer cannot repair the vehicle or does not offer an acceptable remedy, you can file a complaint with the Mississippi Attorney General's Office.

The Attorney General's Office will investigate your complaint and determine if your vehicle qualifies as a lemon. If it does, the office will negotiate with the manufacturer on your behalf to secure an appropriate remedy.

Time Limits for Filing a Claim

There are strict time limits for filing a lemon law claim in Mississippi:

* You must file a written notice to the manufacturer within two years of the date of Free Download or lease. * You must file a complaint with the Attorney General's Office within one year of the manufacturer's final repair attempt.

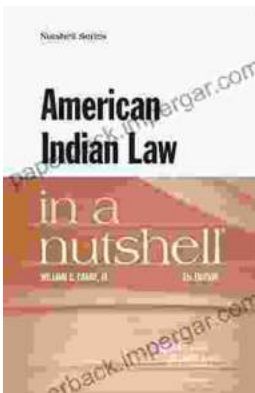

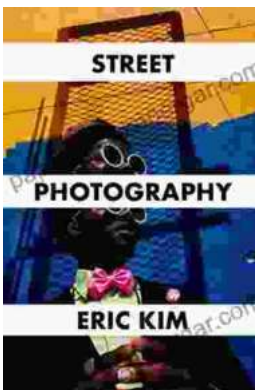
